

Civilek Józsefvárosért Egyesület - Pikó András joint newsletter privacy policy

Data management information for subscribers to the joint newsletter of the Civilek Józsefvárosért Association (registered office: 1084 Budapest, Déri Miksa u. 15 V/1., represented by Ágnes Mező) and András Pikó (office address: 1082 Budapest, Baross u. 63-67.)

The purpose of the following information is to help you, as a subscriber to the joint newsletter of the Civilek Józsefvárosért Association and András Pikó, to find out all important information about the processing of your personal data by the Civilek Józsefvárosért Association and András Pikó.

We process personal data about you

The processing of your data is based on Regulation (EU) 2016/679 of the European Parliament and of the Council of 17 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Regulation (EC) No 95/46/EC (General Data Protection Regulation, hereinafter: GDPR) and Act CXII of 2011 on the Right to Informational Self-Determination and Freedom of Information (Infotv.).

What do we process and why?

Your personal data

- your name, so that we can identify you (required)
- your email address, for contact purposes (required)
- your postcode, for contact purposes, so that we can keep you informed about events in your area (requires)

The purpose of the data processing is to send you the Newsletter and other information about the work, programmes and activities of the Civilek Józsefváros Association and András Pikó based on your subscription.

The legal basis for the processing is that you have given your consent [Article 6 (1) (a) GDPR].

Under Article 9(1) of the GDPR, political opinions are special categories of data, the processing of which is more limited in scope and subject to more stringent safeguards than other processing. As the personal data of data subjects are almost always linked to these special categories of data in the context of the processing of these data by a public office holder and his or her supporting organisation, we will ensure the protection of all data processed about you in accordance with the guarantees laid down in the GDPR for the processing of special categories of data.

Who has access to your data?

The data controller for all the data recorded is the Civilek Józsefvárosért Association (registered office: 1084 Budapest, Déri Miksa u. 15 V/1., represented by Ágnes Mező) and András Pikó (office address: 1082 Budapest, Baross u. 63-67.)

Your data may only be known to staff and volunteers commissioned by the Civilek Józsefváros Association and András Pikó and subject to a data processing agreement, and will not be disclosed to anyone else without your express consent.

Based on the agreement of the joint data controllers, data processing is carried out on the Action Network platform. Action Network (1900 L St NW, Suite 900, Washington DC 20036) is a data processor, its processing activities include providing technical and IT support, providing IT services, providing database management system. What organisational and security measures are in place to protect your data?

The Civilek Józsefvárosért Association and András Pikó store your personal data in a two-factor authentication protected Google Drive account and in the Action Network system, protected by password and two-factor authentication. Paper subscriptions are stored in a vault and digitised on the Action Network platform.

How long do we keep your data?

We will keep your data until you unsubscribe from the Newsletter.

Can you ask for your data to be deleted, rectified or restricted?

You can request the deletion of your data at any time if you no longer wish to receive the joint newsletter of Civilek Józsefvárosért Egyesület and András Pikó.

You may also request the deletion of your data if you consider that the processing is unlawful, that the processing is no longer necessary for the purposes for which it was carried out, or that the data must be deleted pursuant to a legal obligation under EU or Member State law.

You can of course request the rectification of the data processed in the event of incorrect recording or a change in your data.

How can you access information about your personal data and where can you complain about inappropriate processing?

You can request information from Civilek Józsefváros Association and András Pikó about the purposes for which and the way in which we process your personal data, and you can also request a copy of the personal data that we process. We will comply with these requests free of charge.

Your rights of access and use - precisely in order to protect your data - can only be granted after prior identification. We therefore ask you to submit your requests, statements and complaints regarding data processing in writing to kapcsolat@pikoandras.hu.

You also have the right to object to the unlawful processing of your personal data or you may lodge a complaint with the Metropolitan Court of Budapest (1055 Budapest, Markó u. 27., Postal address: 1363 Bp. Pf. 16.) or the competent court of your place of residence, or you may contact the National Authority for Data Protection and Freedom of Information (1055 Budapest, Falk Miksa utca 9-11., www.naih.hu).
